**RESOLUTION TO MODIFY THE COMPENSATION OF THE
VILLAGE OF STOCKBRIDGE PRESIDENT PER
CHAPTER 2, ARTICLE II, SECTION 2-26**

WHEREAS, the Village of Stockbridge Code, Chapter 2, Article II, Section 2-26 (a) provides:

The president and trustees shall each receive a fixed amount established annually by resolution of the council adopted simultaneously with the annual budget of the village. The resolution may also provide for reimbursement of any expenses incurred in the performance of their duties and for additional compensation for any regular or special meetings of the council actually attended by a trustee.

WHEREAS, the Village of Stockbridge has adopted a Manager Ordinance, which is Codified in Chapter 2, Article II, Section 2-46 - 2-54 and the Village previously employed a full-time manager who was compensated approximately \$120,000 per year, including benefits.

WHEREAS, the Village of Stockbridge is considering having the Village President Jill Ogden serve in the role of the Village Manager for \$45,006.00 per year without benefits.

THEREFORE, IT IS RESOLVED:


1. The Village of Stockbridge determines President Jill Ogden shall permanently serve in the role of Village Manager and shall work an average of 30 hours per week for the Village in that role, including all meetings attended. The Village Manager shall work a minimum of 10 of the 30 hours per week in the Village office overseeing the Village staff and being available to the public.
2. Pursuant to Chapter 2, Article II, Section 2-(a) the Village of Stockbridge amends the Village President's salary to \$45,006.00 per year or approximately \$1,731.00 bi-weekly, without additional benefits. The position is a W-2 position. This position will terminate at 12:00 a.m. October 2, 2023.
3. The Village President shall serve in this role at the pleasure of the Village Council and may be removed from this role at any time at a regular or special meeting by a vote of the majority of the council.
4. The Village President shall receive no additional compensation for attending Village Council, Committee, and/or DDA meetings above the \$45,006.00 salary set forth herein.
5. The Village President shall not vote on this Resolution, and, if approved, it shall be signed by the President Pro Tempore to avoid any appearance of conflict.
